CONTINUED FROM PAGE 33 they attended a wedding reception in Sullivan, Wis., not far from Two Rivers in 1980. He also lived just an hour away from Avery's salvage yard in 2005, the same year Teresa was slain.

IN ANOTHER chilling coincidence, Cameron said a shadowy figure ominously appears behind Wisconsin prosecutor Ken Kratz in the sixth episode of the series.

"It looks like Edwards to me," said Cameron, who added that the serial killer was known to show up at court hearings and funerals during high-profile murder cases.

"He got off on that," he added.

He's also convinced that Edwards was involved in the notorious "West Memphis Three" case, in which three teenagers were convicted of killing three young boys during a satanic ritual in Arkansas in 1993 — AND that he briefly appeared in the HBO documentary "Paradise Lost" that chronicled the brutal killings.

The suspects won their freedom in 2011!

Now, Cameron reveals that he can produce one MORE smoking gun that could blow

Avery's conviction out of the water.

The detective reported that a new anonymous note — not too different from the one he sent to the judge presiding over the Abbott trial — was sent to Wisconsin investigators in the Avery case!

"It contained information only the killer could know," said Cameron.

"The letter is referred to as 'cryptic' by the judge, and contained specific details of how Teresa was killed and burned in a smelter. This letter was handwritten in the same way, and I believe it came from Edwards."

But in the rush to convict Avery, the letter was disregarded, said Cameron.

"It needs to be thoroughly examined," he said. "These cryptic letters are Edwards' signature. He's set up Avery, just the way he did with Abbott."

The retired detective has aggressively reached out to prosecutor Kratz and Manitowoc County investigators to mention the dead serial killer's numerous connections to the case.

"He may be dead, but I don't want him to get away with another murder," he said.

Cameron displays sicko tendencies in notes to 'beautiful woman': expert

CAMERON Douglas is not only a jailed junkie — but likely a sexually controlling pervert with an itch for S&M!

The National ENQUIRER can exclusively reveal that Michael Douglas' son has been sending perverted letters to a female pen pal from prison.

Cameron, 37, has been locked up since 2010, following a string of drug convictions, including one for dealing crystal meth.

Since his latest transfer to

a low-security correctional institution in Connecticut, he's been caught exchanging sexually charged mail with a mystery lady!

In a bombshell development, a handwriting expert commissioned by The ENQUIRER has determined the inmate shows signs of being an entitled, sexually controlling deviant who may have sadomasochistic sensibilities.

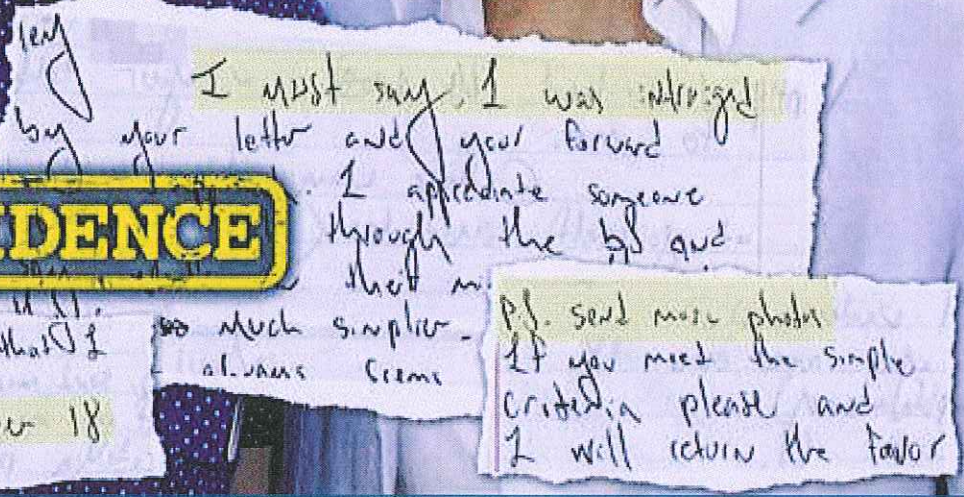

Susan Constantine said. In a two-page letter obtained exclusively by The ENQUIRER, Cameron brazenly requests "more photos" from the woman in return for his own X-rated shots. Handwritten from his prison cell, Cameron scrawls: "I must say, I was intrigued by your letter and your forward approach. I appreciate someone who can cut through the b.s. and say what's on their mind. ... It makes things much simpler. ... So having said that, allow me to be direct with you

... I have a few concerns that I hope you will understand. "1. Is that you are over 18 (self-explanatory) "2. That you are who you say you are, i.e., that the beautiful woman in the picture, and the impressive rhetoric in your letter, is indeed [named redacted]. "So if you can convincingly prove these things to me, and you feel it is worth your time, then I look forward to doing all of those things that you so aptly described in your letter. "P.S. Send more photos if

you meet the simple criteria please and I will return the favor." The contents of the original letter are unknown, but Cameron is clearly eager to reveal his own private photo album to the "beautiful woman." "There is no doubt he is running the show, and she is an active submissive participant," Susan explained to The ENQUIRER. "This is not the first time for him. It wouldn't surprise me if it was an S&M type of an arrangement, because he's the

dominant setting the ground rules and she's the submissive who must abide by the rules." Cameron's fall started in 1999 with his first drug arrest. He was arrested, convicted and sentenced again in 2009. His sentence was lengthened after he was caught with drugs behind bars, and he suffered serious injuries in 2012 when another inmate broke his leg for snitching! Cameron was punished once again in 2013 and sent to solitary confinement after a failed drug test. *ME*
